Scent Work Trial 2021

We held our 2nd Scent Work Trail on the weekend of July 30th, 31st, and August 1st, 2021 at the Nicollet County Fairgrounds in St. Peter, MN. It was a fabulous weekend weather wise and we couldn't have been happier.

On Friday, July 30th, we held the Detective Level for Scent Work, two trials were held. We had Chris Eblen & and Sharon Dowell, both from Iowa judging 11 dogs per trial. Unfortunately we did not have any qualifiers due to the difficulty of the search.

On Saturday, July 31st, we added Linda Spengler from Minnesota to our judging panel. We held 2 trials for each class level, Novice, Advanced, Excellent, and Masters, with all 4 elements, buried, interiors, exteriors, and containers. Trial 1, we had a total of 153 entries and for trial 2, we had 147 entries. Terra Schuster with her Weimaraner, Willow were the recipients for High in Trial at the Novice level for both trials.

On Sunday, August 1st, we kept our class levels and elements the same as Saturday. We had a few hiccups to overcome, but we prevailed. For Trial 1, we had 156 entries and for Trial 2 we had 142 entries. We had 2 recipients for High in Trial: Norma Torres and her All American Dog, Zoe at the Novice Level in Trial 1 and Wendy Henes and her All American Dog, Frankie to the Excellent Level in Trial 2.

Pat Hooey and Sue Fleming did a fabulous job feeding all of the judges and volunteers. We had a little mishap with refrigerator and the ladies had to change up the menu to feed us. We had an issue with the water for the 4-H Food Stand and for the grounds, Brian took charge of that situation for us. We did find the leak for the fair board.

Trial totals were for the weekend are as follows: 620 entries with 55 handlers and 70 dogs.

I would like to thank my committee members for all the work they did. I would like to also thank the club members who volunteered to support this trial.

With this trial under our belts, we be looking at doing some shifting of classes and areas.

The Virtual Scent Work Test is perfect for beginners to Scent Work who are looking to get involved in an activity that utilizes their dog's natural ability to search and detect items – all from the comfort of home.



What is the Virtual Scent Work Test?

The Virtual Scent Work Test requires dogs to prove basic Scent Work skills. Dog and owner teams work against the clock to find specific items (dog toy, ball, treat) in areas like your living room, bedroom, or backyard.



Who can compete?

All registered dogs (purebred and mixed breeds) aged 4 months or older are invited to participate and put their favorite activity (sniffing!) to the test.



How do I participate?

- Begin by hiding your search items within your designated search environment. Use the <u>Virtual</u> <u>Scent Work Guidelines</u> for specifics.
- Simply film you and your dog locating the items within your designated time frame.
- Complete your <u>entry form</u> by filling out your information, uploading your video file, and paying your \$25 fee.
- Once submitted, your performance will be reviewed and scored by official scent work judges.

LIFESAVING AKC PET DISASTER RELIEF TRAILERS DEPLOYED TO 50 LOCATIONS TO HELP DISPLACED PETS

-Emergency Grants Also Provided by AKC Reunite Across the Country-



RALEIGH, NC — AKC Reunite, the largest non-profit pet identification and recovery service provider in the United States, is pleased to announce the 50th deployment of its AKC Pet Disaster Relief trailers. These life-saving trailers donated to local emergency management teams through the AKC Pet Disaster Relief program are available to dispatch to any local disaster scene that needs assistance sheltering pets. AKC Reunite has also provided funds to support the work of organizations that are saving and reuniting pets with their owners during natural disasters.

AKC Pet Disaster Relief is a nationwide program sponsored by AKC Reunite, that is dedicated to keeping pets and their owners safe in response to natural disasters. AKC Reunite partners with AKC® dog clubs and pet lovers to donate lifesaving trailers to emergency management teams across the country. These trailers are stocked with equipment to help create a safe, temporary home-base for at least 65 pets before, during and after a disaster is declared. The trailer's crates and generator can be set up as co-location shelters, where people can evacuate with their pets, as well as emergency animal shelters for displaced animals. Other contents include microchips and scanners, cleaning supplies, feeding bowls, leashes and administrative supplies.

To date, 95 AKC Pet Disaster Relief trailers have been donated to emergency management teams throughout the U.S. On Monday, August 16th, the Arizona Humane Society deployed its trailer to assist with animal sheltering efforts in the wake of the deadly flooding in Gila Bend, AZ. This marked the 50th deployment of these critical trailers throughout the country.

AKC Delegate Report

- 1. I was officially voted in at the August board meeting.
- 2. My first AKC Delegate meeting will be September 13 & 14, 2021 in Newark, NJ
- 3. Votes coming up at the September and December Delegates meeting will be as follows:
 - A. Changing the Charter and By to reflect that when meetings are determined, the date, time, method, and location of all regular meetings shall be determined by the Board. Fourteen (14) days notice of said date must be given to each Director by United States mail, telephone or electronic mail. This will also apply to special meetings with 5 days notice. A new section was also written to include the ability for members not physically present to be able to participate via teleconference or video as long as all persons participating in the meeting can hear each other at the same time and all directors have the ability to participate.
 - B. Rules Applying to Dog Shows to define the miniumum age of eligibility for dogs to compete. This will be read in September and voted on in December to go into effect March 31, 2022.
- The Belgian Malinois Standard and Standard of he Manchester Terrier was approved as revised, and will go into effect in October.
- 5. The Akita Standard (changes to color and nose pigment), Cane Corso Standard (color and nose pigment) Bergamasco Sheepdog Standard and Entlebucher Mountain Dog (color and nose pigment) will go out for comment.
- 6. The AKC sent hundreds of items to the site of the Miami building collapse to support the dogs and handlers that were working there. Items included 50 cooling mats, toys, treats, towels, cooling collars and vests, water bottles and extra ice packs.
- 7. Entries across all venues are increasing. Registrations overall were up over last year, but now that people are going back to work, this will be watched closely.
- 8. In Mid-may AKC registration and IT launched electronic litter kits and about 8.5% of breeders are choosing this method rather than through the mail.
- 9. AKC will be assessing the Competition Management System infrastructure and will be making investments in technology that reduces turnaround times for results, reduces manual internal processing, and has ability to capture other data points. The board voted to approve a process that was outlined including scope of work, budget and timeline.
- 10. AKC Board reviewed a business plan and budget for the AKC Purebred Preservation Bank and voted to approve a plan and move forward with becoming involved in semen banks. There will be more details coming forward in the next months.
- 11. Income and revenue is above last year due to increased registrations and decreased costs as many people are continuing to work from home.

- 12. Registration Statistics 2021 YTD Litter Registration was 22% ahead of budget, with Dog Registrations 33% ahead. Compared to same period in 2020, Events and Entries were up by 87% and 39% respectively.
- 13. Nominating Committee was elected as Melanie Steel (Abilene Kennel Club), Pamela Stacey Rosman (Canaan Dog Club of America), Patti Strand (Dog Fanciers Association of Oregon), Maggie Strouse (National Shiba Club of America), Marilyn Vinson (Southeastern Iowa Kennel Club), and alternates Marge Calltharp (Chinese Shar-Pei Club of America, Inc) and Connie Clark (American Fox Terrier Club)
- 14. Bylaw Amendments to disallow proxy voting and additional language surrounding criteria for club membership to the AKC were voted down and sent back to committee.
- 15. Bracco Italiano has requested acceptance to participate in the Sporting Group and will be discussed further.
- 16. The Board received recommendations to change the Foundation Stock Service Guidelines to include clarifications of the requirements for a breed developed within the US and how clubs will show a plan to maintain for stability and growth over the first 10 years of recognition. Further discussion will be held at a future meeting.
- 17. AKC Family Dog magazine can be found on Amazon.com
- 18. More than 2100 pieces of legislation are being monitored at state, local and federal level.
- 19. Virtual Scent Work Test Pilot Program was approved for 1 year and will offer the titles of VSWB, VSWI, and VSWE
- 20. Fast CAT recommendations will be reviewed further that requires clubs to use electronic timers and hot starts will not be allowed. Will be further discussed
- 21. Recommendations on which dogs can run in Fast CAT competitions will also be discussed further
- 22. Conflict of Interest Statements added to the Field Rep IC Agreement was voted on and approved by the board.
- 23. Bred by Exhibitor Class recommendation to have a divided age group failed and will be discussed further.
- 24. Winners Class and those entries eligible to compete in Winners and Reserve Winners class (language will be inserted to specify dogs eligible to compete are first place undefeated dogs from all divisions of the defined classes and that Am-Bred and Open are only required classes)
- 25. AKC.TV is increasing in downloads and apps.
- 26. AKC has had 39 broadcasts across ABC, ESPN, and Nat Geo networks The AKC National Agility Championship premiered on 3/31 on ESPN2 and was the highest rated show of the day. Because of this, the AKC Agility Premiere was moved to ESPN and was the 7th most viewed sport event of the day of any network.
- 27. Policy approved to allow clubs to appeal where a denial has been issued for an event due to straight miles when the driving miles are significantly higher. (25%) greater. This goes into effect 9/1/21.
