### **Doggie Ice Creams**

One of the best ways to cool down in the summer is with a frozen treat. As humans we have plenty of options, but what about treats to keep our dogs cool in the heat?

Check out these easy DIY ice creams and pupsicle recipes for you and your pup!

Note: dairy products may cause upset stomachs with certain dogs, if your dog has a sensitive stomach, you may want to talk to your vet first.

### **Banana Blueberry Blend**

- 1 cup of blueberries
- 1 banana
- 1 6oz plain yogurt
- 1 tsp of ground flax seed

### Instructions

Mix all the ingredients in a blender until smooth. Distribute the mixture evenly into an empty ice tray. Keep in the freezer till frozen.

### **Pumpkin Surprise**

- 2 bananas
- 2 tbs of organic peanut butter
- 2 tbs of honey
- 2 tbs of pumpkin
- 24 oz of fat free yogurt
- 1 tsp of cinnamon

### Instructions

Mash the bananas in a bowl. Mix in the remaining ingredients and stir well. Pour the mixture into your container of choice and place in the freezer until the mixture has frozen.

### **Key City Kennel Club Agility Trial**

The KCKC Agility Trial will be held August 30, 31, and September 1 - FRIDAY, Saturday, Sunday this year. Please mark your calendars for the following events (dates may change). Join us as you are able, for fun with friends and to help our Trial run smoothly for everyone. **Just like our May show, we will need plenty of volunteers: Please RSVP by AUGUST 25th.** 

- August 25th 3:00 pm Loading of the Trailer at the Training Center
- August 28th 10:00 am Begin prep of fairgrounds area for trial in St. Peter
- August 29th 10:00 am Finish prep of fairgrounds and unload equipment
- August 30th & 31st Trial starts at 8:30 am volunteers need to check in by 8:00 am
- September 1st Trial starts at 8:30 am volunteers need to check in by 8:00 am
- September 1st AFTER last run (between 2 and 3 pm) cleanup of Fairgrounds and load the equipment back into the trailer.

Patty Hooey and Sue Fleming would appreciate some extra help to clean up the Kitchen Area in the 4H Building for our trial. If you are interested in helping, please contact Patty or Sue for dates and times. We will also need your favorite potluck items to add to the meals for all of our hard working volunteers and judges. The club will be providing the main course, but salads, fruits, vegetables, and desserts are needed. Please bring them to the fairgrounds before 10AM on Friday, August 30, 2019. Contact Pat Hooey (507-386-7488) if you have any questions, or if you would like to volunteer anything additional for hospitality.

#### Jobs at the trial

**Scribe** – Responsible for watching the judge for the simple hand signals used to represent course faults.

Assistant Scribe – Responsible for recording the run time from the timer and keeping the scribe's sheets in order for the scribe.

**Timer** – Responsible for starting the dogs when the judge is ready. Uses the electronic timers to time the run and quickly gives the run time to the assistant scribe.

Gate Steward – Responsible for making sure that the exhibitors & their dogs are ready at the starting line. Usually tries to keep 3 dogs ahead to move the trial along quickly. Informs the ring stewards when it is time to change the jump height (usually consists of yelling "last dog this height"), keeps the dogs in catalog order or notifies the assistant scribe of any change in order.

**Course Builder** – Responsible for moving equipment into & around the ring according to the judge's course plan. The course changes from Novice to Open to Excellent so equipment will need to be added and/or removed. After a course is set, the builders won't be needed until a new course change, so these people would be excellent as equipment setters also.

**Equipment Setter/Ring Steward** – Responsible for adjusting the equipment during the runs. These people will need to bring chairs to sit on the edge of the ring and are expected to be ready to adjust anything that needs adjusting.

**Runner** – There are 2 different runners needed: *leash runners & scorecard runners*. The leash runner brings the dog's leash from the starting gate to the finish gate. The scorecard runner takes the finished scorecards from the assistant scribe and brings them to the secretary.

#### Things to Remember

• Our trial is held Outside, but now in a warmer part of the year, be ready for rain or heat and sun. The trial will be held rain or shine!
