
Why Does My Dog Cock His Head?

A dog probably does this to better localize the source of the sound by using a process know as triangulation. In this respect, the dog's ears function as stereo receivers. By altering their position with respect to the sound-source, its location can be more accurately pinpointed. When the dog hears a sound, his brain calculates the delay between the time the sound reaches the ear nearest the sound and when it reaches the ear furthest from it. The difference can be translated to estimate the distance at which the sound source is located. A dogs brain can compute the time difference of the sound's arrival at each ear independently, thus negating the need for the knowledge of suck excruciating facts as the speed of sound or the time the sound takes to travel, and the application of the formula distance = speed*time.

We humans also cock out heads when we want to listen hard, presumably for the same reason. We also need no knowledge of the various physical parameters to make our assessment of the sound's origin. We get a little more fanciful when estimating the distance of a thunderstorm by counting the seconds between the flash, but that's only because someone worked out the calculation.

Diabetic Dog Treats

Ingredients:

- 1/2 Cup Whole Wheat Flour
- 2 eggs
- 1 1/2 lbs beef liver, but into pieces

Directions:

- 1. Preheat oven to 350 degrees.
- 2. Line a 10x15 jellyroll pan with parchment paper
- 3. Place liver in a food processor and pulse until finely chopped
- 4. If there is room, add eggs and flour into the processor. Otherwise combine all ingredients into a bowl. Mix until smooth.
- 5. Spread mixture evenly onto the pan
- 6. Bake for 15 min, or until the center is firm.
- 7. Cool, and cut into squares using a pizza cutter.

Treats will have the consistency of a sponge. Treats should be kept in an air tight container and refrigerated.

AKC Annual Agility Trial

Our 2014 KCKC AKC All Breed Agility Trial will be held Friday, October 3rd through Sunday October 5th at the Nicollet County Fairgrounds in St. Peter. We will begin preparing the fairgrounds on Thursday, October 2nd.

Just like our May show, we will need plenty of volunteers: Please RSVP by SEPTEMBER 20th.

- We are going to be giving away 3 gift cards each day for the workers. We will be giving away 3 gift cards from Super America, Casey's and Kwik Trip. 9 cards total for the weekend. We are asking for a small cash donation from our members to cover the cost of these Gift Cards. Whatever you are able to give towards the purchase of the gift cards would be fantastic. - We will need your favorite potluck items to add to the meal for all of our hard working volunteers and judges. The club will be providing the main course, but salads, fruits, vegetables, and desserts are needed. Please bring them to the fairgrounds before 10AM on Saturday, October 5th. - Our Hospitality crew, Patti Hoey and Joey Heilman, could use some strong hands to load up all the Kitchen equipment before the Agility Trial and then after the Trial getting it back to the Training Center. They would also like a couple more hands helping out during the Trial getting food ready and served. If you would be interested in helping the Hospitality Crew with keeping all of us and our Volunteers well fed, please contact Patti to let her know you are interested and then what help she needs and where and when. Thank you so much gang for everyone that helps out with the Agility Trial.

Scribe – Responsible for watching the judge for the simple hand signals used to represent course faults.

Assistant Scribe – Responsible for recording the run time from the timer and keeping the scribe's sheets in order for the scribe.

Timer – Responsible for starting the dogs when the judge is ready. Uses the electronic timers to time the run and quickly gives the run time to the assistant scribe.

Gate Steward – Responsible for making sure that the exhibitors & their dogs are ready at the starting line. Usually tries to keep 3 dogs ahead to move the trial along quickly. Informs the ring stewards when it is time to change the jump height (usually consists of yelling "last dog this height") Keeps the dogs in catalog order or notifies the assistant scribe of any change in order.

Course Builder – Responsible for moving equipment into & around the ring according to the judge's course plan. The course changes from Novice to Open to Excellent so equipment will need to be added and/or removed. After a course is set, the builders won't be needed until a new course change, so these people would be excellent as equipment setters also.

Equipment Setter/Ring Steward – Responsible for adjusting the equipment during the runs. These people will need to bring chairs to sit on the edge of the ring and are expected to be ready to adjust anything that needs adjusting.

Runner – There are 2 different runners needed: *leash runners* & *scorecard runners*. The leash runner brings the dog's leash from the starting gate to the finish gate. The scorecard runner takes the finished scorecards from the assistant scribe and brings them to the secretary.

REMEMBER: Our trial is held the first weekend of October. The trial will be held at the fairgrounds in St. Peter and we will be at the mercy of the weather. The trial will be held, rain, snow, or shine!
